

Terms and Conditions – Preloved Clothing Market Day Lucky Door Prize Promotion

1. Information on how to enter the **Preloved Clothing Market Day Lucky Door Prize (Promotion)** forms part of the terms of entry. Entry into the Promotion is considered acceptance of these Terms and Conditions (**Terms and Conditions**).
2. The **Promotor** is The Preloved Clothing Market, ABN 117 720 271 40
3. The Promotion runs at each Preloved Clothing Market Day event in 2017 (**Promotion Period**).
4. Entry is open to:
 - a. Anyone who visits the Preloved Clothing Market on Market Day AND provides their name and mobile number on a raffle ticket at the front desk; and
 - b. Any stall holder at that Market Day

6. The winner receives a Complimentary Single Market Stall (valued at \$20) (the **Prize**).
7. Redemption of the Prize is at a Preloved Clothing Market in 2018 held within twelve (12) months of the market date at which the Prize was drawn (**Prize Redemption Period**).
8. The Prize winner will be announced at the Market half an hour before Market close, and on the Promotor's Facebook and Instagram sites.
9. The Promotor reserves the right to determine whether the Prize is available for redemption at any particular Market in the Prize Redemption Period.
10. The Prize winner must be able to redeem the Prize within Prize Redemption Period unless otherwise determined by the Promotor.
11. The Prize is forfeit if, without prior Promotor consent, it remains unredeemed within the Prize Redemption Period.
12. The Promotor will endeavour to contact the Prize winner on Facebook or Instagram. In the event the winner does not respond to these enquiries within 5 days of the draw, or cannot accept the Prize, the Prize will be forfeited by that winner and another name will be drawn and awarded the Prize and so on until a valid winner is found who is able to accept the Prize. The Prize cannot be transferred to another person or event unless determined by the Promotor.
13. The Promotor's decision is final, and the Promotor will not enter into correspondence regarding the result.
14. If the Prize is unavailable, for whatever reason, the Promotor reserves the right to substitute the Prize for a prize of equal or specified value, subject to Tasmanian State Government Regulations.
15. The Prize will be awarded to the person named in the entry.
16. The Prize winner consents to the publication of their name in the Promotor's newsletter, Facebook and any other media for the purposes of promoting the Promotion.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia (Non-Excludable Guarantees). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promotor (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promotor (including its respective officers) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, occurring in Tasmania, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promotor's control); (b) any theft, unauthorised access or third party interference; (c) any entry or Prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promotor) due to any reason beyond the reasonable control of the Promotor; (d) any variation in Prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking/use of and/or participation in the Prize.
19. The Promotor collects personal information (**PI**) in order to conduct the Promotion and may share that PI with third parties for the purposes of providing the Prize.
